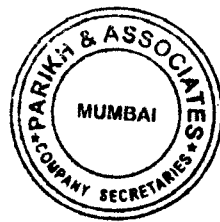




Report of Scrutinizer






