Sub.: Unsolicited messages circulated via WhatsApp qua the share price of The Bombay Dyeing & Manufacturing Limited by Safe Multubaggers, Multibagger Stock Tips, Safemultibaggers In, Fake Tips, FAKE TIPS and Safe Stock Tips

1. Parties:

1.1 Informant:

The Informant herein is **The Bombay Dyeing & Manufacturing Company Limited**, a public listed company, incorporated under the provisions of the Indian Companies Act, 1866 and an existing company under the Companies Act, 2013, having its registered office at Neville House, J. N. Heredia Marg, Ballard Estate, Mumbai 400 001 and corporate office address C1-Wadia International Centre, (Bombay Dyeing), Pandurang Budhkar Marg, Mumbai 400 025.

1.2 Accused:

The Accused herein are **Safe Multubaggers, Multibagger Stock Tips, Safemultibaggers In, Fake Tips, FAKE TIPS and Safe Stock Tips** circulating unsolicited messages via WhatsApp qua the share price of the Informant. The Accused herein are unregistered/unauthorized entities.

2. Facts:

2.1 On 10.04.2023 and 11.04.2023, the Informant, *vide* email dated 10.04.2023, 11.04.2023, addressed by Mr. Fahad Kapadia of BSE Limited and Mr. Megh Maheshwari of National Stock Exchange of India Limited (NSE), wherein the shares of the Informant are listed and learnt that the Accused herein are

circulating on unsolicited messages qua the share price of the Informant on WhatsApp. Enclosed hereto is a copy of the email dated 10.04.2023 and 11.04.2023 addressed by Mr. Fahad Kapadia of BSE Limited(BSE) and Mr. Megh Maheshwari of National Stock Exchange of India Limited (NSE) along with its attachment.

- 2.2 Upon learning about the same, the Informant, immediately, *vide* its letter dated 11.04.2023 addressed to Mr. Fahad Kapadia of BSE and Mr. Megh Maheshwari of NSE, informed that it was neither aware nor had the knowledge of the unsolicited messages circulated by the Accused on WhatsApp qua the share price of the Informant and that it learnt about the same only upon the receipt of the email dated 10.04.2023 and 11.04.2023 addressed by Mr. Fahad Kapadia of BSE and Mr. Megh Maheshwari of NSE. Further, Mr. Fahad Kapadia of BSE and Mr. Megh Maheshwari of NSE were informed that the Informant is conducting an inquiry qua the unsolicited messages circulated by the Accused on WhatsApp and will take appropriate action. Enclosed hereto is a copy of the letter dated 11.04.2023 addressed by the Informant.
- 2.3 **Accordingly, we conducted the inquiry/investigations *qua* the originator (is Accused) of this messages and the details with respect to the mobile number of the concerned Accused is provided in Annexure A of this complaint.**
- 2.4 Thereafter, Mr. Fahad Kapadia of BSE, *vide* his email dated 11.04.2023 and Mr. Megh Maheshwari of NSE through his telephonic call on 13.04.2023, *inter alia*, suggested the Informant to lodge an FIR against the originator of such unregistered entities and provide a scanned copy of the same to him. Enclosed hereto is a copy of the email dated 11.04.2023 addressed by Mr. Fahad Kapadia of BSE Limited.
- 3. Submissions:**
- 3.1 In view of the afore said, it is clear that the Accused are circulating reckless and false messages on WhatsApp qua the share price of the Informant, which is a prestigious and reputed listed company and does not indulge in such criminal activities, whereas the Accused are unregistered/unauthorized entities.
- 3.2 It is pertinent to mention here that increase or decrease in the share price is a market driven phenomena, which is not under the control of the Informant.

- 3.3 The Accused are circulating false information qua the share price of the Informant with the sole intent of cheating and harming the interest of investors and shareholders of the Informant.
- 3.4 The Accused are attempting to create a false narrative qua the share price of the Informant by circulating the unsolicited messages. It is, therefore, necessary, as a precautionary measure that the present Complaint is being filed before you to protect the Informant from the repercussion and/or aftermath of the unsolicited messages circulated by the Accused and to take necessary action, as deemed fit under the law, against the Accused.

4. Jurisdiction:

- 4.1 The offences committed by the Accused fall within the jurisdiction of your Police Station, as: (a) the emails dated 10.04.2023 and 11.04.2023 addressed by Mr. Fahad Kapadia of BSE and the emails dated 11.04.2023 addressed by Mr. Megh Maheshwari of NSE were received by the Informant at Wadia International Centre, Pandurang Budhkar Marg, Worli, Mumbai 400 025; and (b) the emails dated 10.04.2023 and 11.04.2023 addressed by Mr. Fahad Kapadia of BSE and the emails dated 11.04.2023 addressed by Mr. Megh Maheshwari of NSE were responded by the Informant from its office at Wadia International Centre, Pandurang Budhkar Marg, Worli, Mumbai 400 025.

Therefore, the Informant requests that an FIR be registered forthwith to ensure that the Informant and its management is not falsely implicated in furtherance of and/or on account of the unsolicited messages circulated by the Accused *via* WhatsApp qua the share price of the Informant.
