SUB: DISCLOSURE UNDER REGULATION 30 OF SEBI (LISTING OBLIGATIONS AND DISCLOSURE REQUIREMENTS) REGULATIONS 2015 ("LISTING REGULATIONS").

In terms of the provisions of Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, this is to inform that;

The Company and Axis Bank Limited have been engaged in certain disputes/arbitration. Axis Bank Limited has challenged the Award dated March 11, 2022 passed by the Hon'ble Arbitrator in favour of the Company.

The parties have settled their dispute and the Company has also executed a Conveyance Deed on 4<sup>th</sup> September 2023 in favour of Axis Bank Limited effecting transfer of land admeasuring 11,541 square meters, which will enable independent and exclusive access to Axis Bank's headquarters, for an approximate sum of Rs. 149 Crs., subject to conventional terms and conditions.

The Company had made a disclosure of the dispute on August 14, 2023 (see Annexure I thereof, Point No. 3). The Company has also settled this dispute fully and finally.
