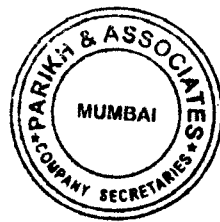



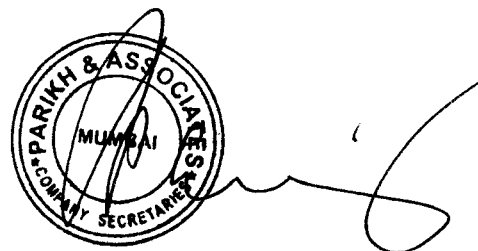
**Report of Scrutinizer**






